**Who is running this weekend?** The weekend is organized and ran by SO-FLO, the South Florida PCA Student Ministry, which consists of youth pastors from churches in Miami-Dade, Broward, & Palm Beach counties. SO-FLO is renting out the Life for Youth Camp in Vero Beach facilities for this event.

**Will my student be safe?** The entire weekend is designed with the safety of the students in mind. As with all activities, the possibility exists for accidents and injuries to occur. Measures will be taken to maintain the highest level of safety while students enjoy the activities.
